


## WARRANTY


## PULSE GENERATOR TEST ARRANGEMENT



- The equipment should be connected in the general fashion shown above. Since the AVO unit provides an output pulse rise time as low as 100 nsec a fast oscilloscope (at least 50 MHz and preferably 200 MHz) should be used to display the waveform.
- 2) The sync output channel provides TTL level signals. To avoid overdriving the TRIG input channel of some sampling scopes, a 30 db attenuator should be placed at the input to the sampling scope trigger channel.
- 3) To obtain a stable output display the PRF and PRF FINE controls on the front panel should be set mid-range. The front panel TRIG toggle switch should be in the INT position. The front panel DELAY control and the scope triggering controls are then adjusted to obtain a stable output. The scope may then be used to set the desired PRF by rotating the PRF and PRF FINE controls. The main output is delayed with respect to the SYNC output by about 0 to 1 usec depending on the DELAY control setting.
- 4) The output terminals of the pulse generator module consists of a short length of microstrip transmission line protruding from the module chassis. The OUT terminal is the center conductor which is bounded on both sides by the ground plane (see below):



The load should be connected between the OUT and GND terminals using very short leads ( $\leq 2.0 \text{ cm}$ ). The voltage across the load may be monitored by connecting a length of 80 mil semi-rigid 50 ohm cable as shown below (or by means of a high impedance scope probe):



Take care to insure that during soldering the OUT conductor is not shorted to the chassis. Also, use minimal heat when soldering.

- 5) The output pulse width is controlled by the 3 position range switch and one turn fine control.
- 6) The output amplitude is controlled by the amplitude of the DC potential supplied to the rear panel AMP terminal.
- 7) An external clock may be used to control the output PRF of the unit by setting the front panel TRIG toggle switch in the EXT position and applying a 0.2 usec (approx) TTL level pulse to the TRIG BNC connector input. For operation in this mode, the scope time base must also be triggered by the external clock rather than from the SYNC output.

- 8) The AVO-7 is designed to supply up to 40 amperes to a maximum load voltage of 20 volts. Factory tests are conducted with a 0.5 ohm load capable of dissipating at least 400 watts. Higher load resistance values may be used but the output voltage must be limited to 20 volts or less.
- 9) <u>CAUTION</u>: The AVO-7-C is designed to operate with a maximum duty cycle of 50%. For example at PRF up to 2 KHz, the full 250 usec PW may be employed. At 20 KHz PRF, the maximum allowable PW is reduced to 25 usec. The output switching elements may fail if the duty cycle rating is exceeded. Heating and subsequent likely failure of the output stage is reduced if the following action is taken where possible:
  - a) PRF is kept to a minimum, ie. operate in the LOW PRF range when possible rather than in the HIGH range.
  - b) Keep the output PW to a minimum.
  - c) Keep the load resistance as high as possible.
- 10) The unit can be converted from 110 to 220V 50-60 Hz operation by adjusting the voltage selector card in the rear panel fused voltage selector cable connector assembly.



- (1) <u>ON-OFF Switch</u>. Applies basic prime power to all stages.
- (2) <u>PRF Control</u>. Varies PRF from about 20 Hz to about 20
  (3) KHz. The operating PRF should be set using a scope. Do not exceed duty cycle rating of 50%.
- (4) <u>DELAY Control</u>. Controls the relative delay between the reference output pulse provided at the SYNC output (6) and the main output (8). This delay is variable over the range of 0 to about 1 usec.
- (6) <u>SYNC Output</u>. This output precedes the main output (8) and is used to trigger the sampling scope time base. The output is a TTL level 100 nsec (approx.) pulse capable of driving a fifty ohm load.
- (7) <u>PW Control</u>. A one turn control and three position range switch which varies the output pulse width from 1 usec to 250 usec.
- (8) <u>OUT Connector</u>. A multi pin connector which attaches the 2 foot cable from the pulse generator module to the main frame.
- (9) <u>EXT-INT Control</u>. With this toggle switch in the INT position, the PRF of the AVO unit is controlled via an internal clock which in turn is controlled by the PRF controls. With the toggle switch in the EXT position, the AVO unit requires a 0.2 usec TTL level pulse applied at the TRIG input in order to trigger the output stages. In addition, in this mode, the scope time base must be triggered by the external trigger source.
- (10) <u>TRIG Input</u>. The external trigger signal is applied at this input when the EXT toggle switch is in the EXT position. The output pulse appears about 60 nsec after the application of the TRIG pulse.





- (1) FUSED CONNECTOR, VOLTAGE SELECTOR. The detachable power cord is connected at this point. In addition, the removable cord is adjusted to select the desired input operating voltage. The unit also contains the main power fuse.
- (2) <u>AMP</u>. The output amplitude from the AVO-7A-PG module is proportional to the DC voltage applied at this terminal (0 to -30 volts, 0 to -20 amps).
